1. Election of the office bearers and members of Executive Council of Kerala Hockey and Representatives to Hockey India will be held as per its Constitution and following the Election Bye-Laws of Kerala Hockey, so far as it applies.
2. The finalization of the Electoral Roll will be undertaken by the State Election Commissioner. Upon publication of the final Electoral Roll, all subsequent election proceedings will be conducted by the Returning Officer.



3. Nominations are to be submitted in the prescribed form available at the office of the Returning Officer (**Adv. Sandeep T George, T C 11/292, # B 7 & B 10 Kowdiar P.O, Christ Nagar, Trivandrum - 695003**) after the publication of Final Electoral Roll.
4. Only the nominees representing the District Hockey Associations affiliated with the Kerala Hockey, 2 Sportspersons of outstanding merit and Athletes Committee Representatives are allowed to cast the vote as well as to submit the nomination.
5. The Electoral Roll shall be published in the website of Kerala Hockey, Notice Board of Kerala Hockey and Office of Returning Officer.
6. The Nomination of a candidate for election as office bearer or a member of Executive Council shall be proposed by one of the nominees whose name is included in the Electoral Roll and also subscribed by one such nominee as seconder.
7. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been signed by the Returning Officer.
8. A list of all nominations received within the stipulated time will be published, post wise, at the office of the Returning Officer or the place authorised by the Returning Officer.
9. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder.
10. Election by secret ballot will be adopted if the number of nominations received for any/each post is more than the approved number of any/each posts.
